

## Permanent Mission of Turkmenistan to the United Nations Office at Geneva

The Permanent Mission of Turkmenistan to the United Nations Office at Geneva presents its compliments to the International Road Transport Union (IRU) and has the honour to inform the followings.

In order to improve cargo transportation in our country by cargo trailers and semi-trailers of foreign states and increase competitiveness in international transport in the field of transport, the President of Turkmenistan signed the Resolution, in accordance with which: in case of non-use of towing truck of foreign states when importing goods to Turkmenistan and passing through the territory of Turkmenistan cargo trailers and semitrailers of foreign states from the countries participating in the Agreement between the Governments of the Islamic Republic of Iran, the Sultanate of Oman, Turkmenistan and the Republic of Uzbekistan on the creation of the International Transport and Transit Corridor (Ashgabat Agreement) and Agreements on transit and transport cooperation (Agreement on the Lapis Lazuli route) or transit through these states, for the period from November 15, 2021 to November 15, 2022, corresponding payments and fees from their owners have been established.

Moreover, the Permanent Mission of Turkmenistan herewith attaches the list of Rates of fees and charges collected from the owners of cargo trailers and semi-trailers of foreign countries traveling to Turkmenistan and passing in transit.

In this regard, the Permanent Mission kindly requests the IRU to transmit this information to the attention of interested parties.

The Permanent Mission of Turkmenistan to the United Nations Office at Geneva avails itself of this opportunity to renew to the International Road Transport Union (IRU) the assurances of its highest consideration.
